Item

1. Welcome

SP welcomed GIPC to the meeting. JC was introduced as the guest actuary and KH was introduced as the Institute's Member Engagement Manager.

SP reminded GIPC to be cognisant of competition law requirements in discussions and in its work.

2. Institute volunteer program update

KH shared changes to the volunteer recruitment process with GIPC. The comments / discussions noted included:

- KH acknowledged the work that is being done by the Institute's volunteers
- Institute is launching a new online process where members can log their areas of
 interest, which will enable PC's to engage with volunteers. Institute is
 encouraging PCs to reach out to KH if there are any opportunities
- Members are interested in volunteering, however are often time poor, so bite sized opportunities are a good way to engage members
- The issue of how to spread the volunteer network further and engage newly qualified actuaries was discussed
 - May consider an annual survey to collect this information (CAS issues an annual survey)



- Currently volunteer opportunities are advertised via Institute comms (including the GIPC newsletter), however we don't know what the readership rates for these are
- Some potential opportunities for us include increased marketing at the professionalism course
- There will be a volunteer event in late 2023, after this was cancelled for a number of years

The following action items were agreed:

3. Minutes from previous meeting

Minutes from the previous meeting were ratified.

Actions on the task list and request list were reviewed.

The comments / discussions noted included:

- There has been a group set up to assist with the Institute's paper on funding for the costs of flood, led by Evelyn Chow. Paper is expected to come to GIPC in May for approval
- Two outstanding actions in the requests list one is to find a GI volunteer for budget night, the other is finding GI "hosts" for the networking sessions at the ICA to help connect people, etc.
- There has been a question raised with GIPC on the reduced availability of 10+ year yield curves from the RBA, resulting in a need to resort to paid services. It was raised that Institute may seek to take it up with the RBA to raise awareness of the impact of removing this access as a first port of call, prior to considering other options

The following action items were agreed:

 VB to follow up to see if the Institute can assist in finding a solution around RBA's removal of 10+ year yields (MP to forward on email chain)

4. Risk register

MY led a discussion on employment supply and demand risks in the risk register. The comments / discussions noted included:

- Demand risk medium residual risk. Agreed to retain current rating and comments. There have been actions to market our brand
- Supply risk (including not having sufficient actuaries at each level in the market)
 low risk. The areas discussed were the retention of actuaries in non traditional areas (will they remain members with Institute) and traditional areas (will they lose



attractiveness if younger actuaries prefer non traditional areas, resulting in an actuary shortfall). Education program changes may help with retention. It was discussed that traditional areas remain attractive

Decline in seniority of actuaries – low risk. It was noted that there appears to be
more actuaries working in management roles in LI compared to GI, which may
due to the longer historical involvement of actuaries in LI and the more recency
of GI. One area to consider for GI is how to get actuaries into wider roles; is there
further education or support to assist, can we showcase career paths (e.g.
Insights, more general business mentoring)

The following action items were agreed:

 MY to discuss with JP re setting up an Insights session to showcase wider career paths in GI

5. International Actuarial Association

The comments / discusssions noted included:

- IAA General Insurance Forum (GIF) will be having a strategy dicussion on their purpose, which includes facilitation of knowledge sharing between actuarial associations. Does GIPC have any feedback or suggestions on the IAA GIF's purpose?
- Recent discussions at the IAA GIF cover EU's proposed Artificial Intelligence Act
 (this is drafted similar to GDPR, with significant penalties for non-compliance,
 proposed to come into effect in 2025), climate change activities, inflation
 (difficulty in estimating magnitude and duration of elevated inflation levels,
 breadth of approaches being taken)
- Upcoming topics for discussion at the IAA GIF include bias in insurance, actuaries in non traditional areas and PFAS (forever chemicals)

The following action items were agreed:

 GIPC to provide any feedback on IAA GIF's purpose (MP to send note to GIPC for feedback)

JC shared her observations on the GIPC meeting, and this raised discussion on how we can improve on engagement of actuaries from overseas.
