#### Item

#### 1. Welcome

SP reminded GIPC to be cognisant of competition law requirements in discussions and in its work.

#### 2. Minutes from previous meeting

Minutes from the previous meeting were ratified.

Actions on the task list were reviewed.

#### 3. Updates since previous meeting

The comments / discussions noted included:

- Pricing David Millar from LIWMPC has contacted MG with ASIC scrutiny on pricing also extending into life insurance
- General Institute will be holding a session with Council and PC convenors on strategy

#### 4. APRA

The comments / discusssions noted included:

- APRA has released information papers on its policy and supervisory priorities for 2023-24
- Policy priorities include 1) modernising prudential architecture, 2) finalising a number of cross practice standards / guidance (covering CPS900 (plus guidance



on CPS900 and CPS190), CPS230, CPS511), 3) reviewing CPS510 and CPS520, 4) reviewing framework on groups, 5) reviewing insurance prudential framework and GPG240 insurance risk prudential practice guide

 Supervisory priorities include 1) resilience in relation to cyber, climate and operational risks, 2) lifting culture, governance and accountability, 3) resolution, recovery and exit planning, 4) focus on insurance affordability, availability and sustainability, 5) incorporating learnings from insurers' 2022 self assessments

#### 5. GIPC strategy session

A discussion on priorities for 2023, progress with 2022 activities and new items was held. A summary to be presented to next GIPC, with the following actions noted –

- A dedicated time spot at a future GIPC on professional standards. These are important and where GIPC adds value noting SL's work has been acknowledged in this area. Aim of session is to ensure GIPC understand the standards in place, the age of standards and confirm priorities and any missing guidance
- Establishment of a Natual Peril working group. This could include 1) what does a P&C actuary need to know and do (considerations for reserving, professional standards, affordability, budgeting, impacts on RI), 2) involvement in submissions and industry developments that are more GI specific (e.g. natural cat impacts on GI, pools, etc.). BR to consider next steps
- Bring a friend to be restarted in March, which will involve a GIPC member inviting a guest to observe a meeting and sharing their observations / feedback around GIPC
- Personal injury working group will commence in March and will firstly look across what GIPC does (e.g. in professional standards) with a personal injury lens to identify any areas of focus
- Other topical areas
  - o Affordability and inflation this may be an emerging area of focus
  - Marketing, branding and promotion Institute already has its own marketing team supporting Institute wide activities. However there is potential for increasing awareness and promotion of GIPC activities via our communication channels

The following action items were agreed:

- MP to create a roster for bring a friend for 2023
- MP to add agenda item at future GIPC on professional standards
- SP to summarise discussions from Feb strategy session for endorsement at March meeting



#### 6. CPD

ZC provided an update on events. The comments / discussions noted included:

- Insights currently one Insights booked in (cyber) and there are 5 more slots for
  GI. It would be preferable to schedule one for April ahead of the ICA in May to avoid a squeeze in H2
- ICA preparation is going well. Registrations are expected to increase with a \$400 discount up to the end of Feb. ~40% of registrations are from overseas. Abstracts for concurrents are online and the timetable will be released. PCs may be asked for assistance with chairs for sessions. Institute can help with advertising if GIPC wishes to run any side events
- IDSS Ash Evans was approved as convenor and an organising committee has been established (will begin to meet in 2 weeks). Organising committee will provide updates to GIPC
